Privacy Policy

As a not for profit organisation working predominantly on a volunteer basis, we are committed to protecting your personal information as well as maintaining the trust of every one of our supporters.

Our Privacy Policy provides detailed information on when and why we collect your personal information, how we use it, and how we keep it secure.

We collect data when you interact with us in any of these ways:

- Sign up to our mailing list via our mailing list provider Sendinblue
- Provide us your personal information when attending an event that we organized
- Shop from our website
- Make a donation
- Contact us for any reason (e.g. enquiries, help, request of information) through one of the @cuntemporary.org email accounts
- Complete an online survey or audience data survey about one of our events
- Download a free item from our website
- Attend or sign up to one of our events
- Apply to one of our opportunities (open calls, volunteering, job positions)
- Speak to a member of our team about receiving information about our events

The types of information we collect

The type of information we collect depends on the way it is gathered (see above). We may collect:

- email
- name
- surname
- website
- organisation
- role
- city
- country

How we use your personal information

We collect your personal information solely on the basis of your interest in the arts at the intersections of queer, feminist or decolonial discourses; in relation to our activities (such as the regular bi-annual club nights Deep Trash); and in relation to your support of CUNTemporary. This means that we will contact you through your email address for the following reasons:

- To send you our monthly newsletter with a selection of feminist and queer events taking place in London.
- To inform you about the exhibition-cum-performance-club-night Deep Trash, our symposiums and other events that we curate.
- To send you relevant news concerning our activities.

Data hygiene

From time to time we may screen our database and cleanse our files for inaccurate data. We may also update inaccurate data if the information is available.

How we protect your data

- We will never pass on your data to third parties without your consent.
- You have the right to have your data removed from our records at any time without explanation.
- You have the right to request the data we store on you at any time without cost or explanation.
- This policy is drafted in accordance with the EU General Data Protection Regulation. We actively monitor current data regulation and update our data policy where necessary.
- Any storage of data is kept in password protected systems.
- We do not store or have access to credit card details.

We keep a record in a password protected document of when you signed up to the newsletter so that in 5 years after the sign-up date, we can contact you and check if you still want to receive updates from us.

You have the right to unsubscribe and have your data removed at any time. To do so, you can unsubscribe by clicking [here](#).

How we use cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use Google Analytics to identify which pages are being used. This helps us analyse data about web page traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes.

Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.

You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. This may prevent you from taking full advantage of the website.

Links to other websites

Our website may contain links to other websites of interest. Once you have used these links to leave our site, you should note that we do not have any control over that other website. Therefore, we cannot be responsible for the protection and privacy of any information which you provide whilst visiting such sites and such sites are not governed by this privacy statement.
